Steve Reed, OBE MP – Shadow Minister (Digital, Culture Media and Sport) (Civil Society) Honorary President of the CCIN

Steve Reed is Labour and Co-operative MP for Croydon North. As Leader of Lambeth Council (2006-12) he established the country’s first co-operative council and the Co-operative Councils Innovation Network working across local government to find new ways to empower citizens and communities. He set up the country’s biggest community youth trust, a social enterprise that trains unemployed people to bring empty homes back into use and oversaw the country’s biggest asset transfer turning a derelict school site into a community hub. He has introduced a bill to stop the use of abusive restraint against people with mental ill health which is on track to become law this year.
