

What are community shares?

- A flexible form of raising equity investment & building a membership unique to cooperative and community benefit societies
- Withdrawable, not transferable share capital
- Democratic, patient and flexible, you set the terms

Who can offer community shares?

The following society forms, registered with the FCA.

- Co-operative society member benefit
- Community Benefit Society (CBS) community benefit
- Charitable CBS public benefit

Share interest, dividends & plan to gradually return capital

Why use them?

- A resilient business model
 - 92% still trading
- Attracts other investment
 - An additional £1.18 for £1 invested
- Compelling stories
 - 80% of people invest because of the wider social or environmental benefits


Cammunity Shares

Exchange Erith

- Grade II listed Carnegie library in Erith, Bexley
- Transferred from council on 50 yr lease
- 464 shareholder members raised £150k
- £3.5m refurbishment into a community of makers




Projekts Mcr

- Skate park in central Manchester
- Community asset transfer, long term lease
- 70 shareholder members raised £130k
- Further investment to expand site, for social inclusion activities, homework club, female skating sessions

History of grass roots activism

 Close work with council & housing departments to buy, transfer, refurb and let houses. Initially started with round 1 community led housing money

Formed a new community benefit society

Raised £500k from 162 investors
